DESCRIPTION:

Product is the lyophilized powder of human IgG F(ab')₂ and buffer salts.

Human IgG F(ab')₂ is prepared from human IgG by limited digestion with pepsin, and purified by gel filtration or affinity chromatography. The product is dialyzed into 0.01M sodium phosphate, 0.07M sodium chloride, pH 7.3, filtered through a 0.22 µm filter, vialled and lyophilized. No preservative has been added.

SPECIFICATIONS:

The product is tested for purity at a minimum of 20 mg/ml using immunoelectrophoresis. The product is human IgG F(ab')₂; no trace of IgG Fc, IgA, IgM or non-immunoglobulin serum proteins is detected.

The total protein is determined using the Biuret procedure, with bovine albumin as the standard. Each vial is overfilled by approximately 10 percent so that a minimum of 10 mg of human IgG F(ab')₂ is obtained upon reconstitution.

EXPIRATION DATE:

RECONSTITUTION:

Reconstitute product with 1 ml of deionized or distilled water. Gentle swirling may be used to speed rehydration. Avoid vigorous shaking of the reconstituted material.

STORAGE:

Store unopened product at 2-8°C. Store reconstituted material no longer than a few days at 2-8°C unless sodium azide is added. For long-term storage, aliquot and freeze at -20°C.

WARNING AND CAUTION:

This product is intended **FOR RESEARCH USE ONLY**, not for use in diagnostic or therapeutic procedures involving humans or animals.

All blood products should be treated as potentially infectious. Source material from which this product was derived was found negative when tested in accordance with current FDA required tests. No known test methods can offer assurance that products derived from human blood will not transmit infectious agents.
