**RABBIT ANTISERUM TO

Description:

Product is the lyophilized powder of Rabbit Antiserum to Dog IgG (whole molecule) and buffer salts.

The antiserum is prepared by hyperimmunizing rabbits with highly purified dog IgG; antiserum is delipidated and made specific by solid-phase absorption. The resulting antiserum is dialyzed into 0.02M sodium phosphate, 0.14M sodium chloride, pH 7.3, with 0.05% sodiumazide, adjusted to standard titer, filtered through a 0.22 μ m filter, vialled and lyophilized.

Uses:

This product is suitable for use as a precipitating antibody. It gives sharp precipitin lines in immunoelectrophoresis and immunodiffusion techniques.

Note: IgG fractions are suitable for conjugation with enzymes, radiolabels, fluorochromes or other markers and for attachment to solid supports for use as an immunoabsorbant. **See Related Product Ordering Information for these products.**

Specifications:

The total protein is measured using the Biuret procedure, with bovine albumin as a standard. Antibody titer is standardized by equivalence-point precipitation. Each antiserum is tested for specificity at a minimum of 80 mg/ml using immunoelectrophoresis. It shows reactivity to dog IgG; cross-reactivity to other species may exist. Because the product is directed against whole IgG, some antibodies are expected to bind light chain sites common to all immunoglobulins. Antibody activity to non-immunoglobulin serum proteins is not present.

Expiration Date:

Storage:

Store liquid product at 2-8°C. Store liquid product 4 weeks at 2-8°C. For long-term storage, aliquot and freeze liquid product at -20°C or lower.

Reconstitution:

Reconstitute product with 2.0 ml of deionized or distilled water. Gentle swirling may be used to speed rehydration. Avoid vigorous shaking of the reconstituted material.


Warning & Cautions:
